Economic Forum Summary







In 2016 and 2017, ACI was ranked 13th globally, 2nd in Asia and 1st in Singapore amongst 90 think tanks worldwide under the "Best University Affiliated Think Tank" category by the Think Tanks and Civil Societies Program at the University of Pennsylvania, USA.

The Asia Competitiveness Institute (ACI) was established in August 2006 as a research centre at the Lee Kuan Yew School of Public Policy (LKYSPP), National University of Singapore (NUS). It aims to build the intellectual leadership and network for understanding and developing competitiveness in the Asia region. ACI seeks to contribute to the enhancement of inclusive growth, living standards and institutional governance through competitiveness research on sub-national economies in Asia. It identifies mitigating issues and challenges for potential public policy interventions through close collaboration with regional governments, business corporations, policy think-tanks and academics. ACI's three key research pillars include (i) sub-national economies level competitiveness analysis and city-level liveability analysis, (ii) firm-level competitiveness analysis in 16 Asia economies, and (iii) Singapore's long-term growth strategies and public policy analysis.

ACI's value proposition may be encapsulated in an acronym:

Analytical inputs to initiate policies for policy-makers and business leaders in Asia

Capacity building to enable others through improvement in productivity and efficiency

Intellectual leadership to create pragmatic models of competitiveness and inclusive growth

The institute's core research competencies can also be encapsulated in this acronym describing our evidence-based assessments conducted on public policies for ASEAN in the context of the rise of China and India.

Economic Forum Highlights

The ASEAN Economic Forum is part of a series of annual events organised by Asia Competitiveness Institute (ACI) at the Lee Kuan Yew School of Public Policy (LKYSPP), National University of Singapore (NUS), to present its preliminary research findings and concurrently solicit comments and suggestions from prominent policy advisers and scholars. In so doing, ACI aims to facilitate the exchange of views and information regarding topics pertinent to the economies of ASEAN's 10 member states, with a particular interest in Indonesia. At the same time the forum explores possible improvements and expansions of ACI's research work on the topic. Thereafter, ACI would undertake to publish a book, journal papers and policy briefs for all topics presented, incorporating expert views and informed opinions.

The 2016 ASEAN Economic Forum began with **Professor Kishore Mahbubani**, Dean of LKYSPP, NUS, delivering the welcome remarks. Professor Mahbubani welcomed all attendees to the conference and commented on the progress that had been made by ASEAN as an economic and political bloc since its inception while lamenting the fact that it, and the region of Southeast-Asia more generally remained understudied. Professor Mahbubani also thanked the Guest-of-Honour **Mr Ong Ye Kung**, **Acting Minister for Education and Senior Minister of State for Defence**, as well as other Distinguished Speakers and VIP guests for making time to attend the event.

Minister Ong then witnessed, alongside representatives of ACI, the signing of a Memorandum of Understanding (MOU) between the National University of Singapore and the World Bank, which were represented by Professor Tan Eng Chye, Deputy President (Academic Affairs) & Provost, NUS and Mr Jordan Z Schwartz, Director of the World Bank in Singapore, respectively. Both Professor Tan and Mr Schwartz delivered remarks on the research collaboration and what it entailed, after the signing was completed.

These remarks were followed by three Speeches by Distinguished Speakers. The Distinguished Speakers were **Tan Sri Rastam Mohd Isa**, Chairman and Chief Executive of the Institute of Strategic and International Studies (ISIS), Malaysia, **Dr Gilberto M. Llanto**, President of the Philippine Institute for Development Studies (PIDS), Philippines, and **Dr Nguyen Dinh Cung**, President of Central Institute for Economic Management (CIEM), Vietnam.

Tan Sri Rastam expressed his satisfaction at the fact that his Institute of Strategic and International Studies had signed a Memorandum of Understanding with ACI just the previous year. He then commented on the changing circumstances which ASEAN would face in coming years, asserting in particular the need for ASEAN to meet the challenges posed by the rise of new technologies. He also suggested that ASEAN's consensus based framework for decision-making be reviewed in order to facilitate nimbler decision-making. Tan Sri Rastam expressed confidence in ASEAN's economic potential and highlighted in particular the importance of growing middle classes in many of ASEAN's member states in ensuring that this potential was fully achieved.

Dr Llanto spoke at length on the strengths and weaknesses of ASEAN's economies, emphasizing firstly the bloc's laudable growth rates, which were indicated by a significant rise in ASEAN's share of global GDP from 2.6% in 2009 to 3.2% in 2014. However, Dr Llanto also expressed caution regarding the potential vulnerability of ASEAN nations, given their inevitable need to transition away from the manufacturing sectors that had been their bread and butter. Dr Llanto then proposed several solutions to these and other challenges that he had highlighted, placing emphasis on the need for both greater access to education at all levels, and a wider uptake of Information and Communications Technologies.

Dr Nguyen Dinh Cung addressed two major challenges ASEAN would face in the near future. The first was ASEAN's consensus-based decision-making process, which Tan Sri Rastam had previously touched upon.

Describing it as an impediment to decisive action, Dr Nguyen Dinh Cung stressed the need for more streamlined and expedited processes, in order to prevent delays and miscommunications that would handicap ASEAN's ability to properly respond to potential difficulties. The second challenge he highlighted was the gap which existed between ASEAN's advanced and developing economies, which he attributed to the misallocation of resources, and a general resistance within many developing economies to change. Dr Nguyen Dinh Cung concluded by expressing his hope that Singapore could serve to provide its neighbours with a framework for success.

The Economic Forum's first session, entitled "2016 Annual Update on ACI's Competitiveness Ranking and Simulations of ASEAN-10" was moderated by Dr Mulya Amri, Research Fellow and Deputy Director (Research) of ACI. The presenters were Ms Nguyen Le Phuong Anh, Research Fellow and Deputy Director (Admin) of ACI, Mr Luu Nguyen Trieu Duong, Research Assistant at ACI, and Associate Professor Tan Khee Giap, Co-Director of ACI. The presenters showcased ACI's 2016 competitiveness rankings of the ASEAN-10 nations, explained ACI's competitiveness framework and methodology, and highlighted some interesting results from the 2016 Competitiveness Ranking and Simulations.

The session's discussants were **Tan Sri Rastam Mohd Isa**, Chairman and Chief Executive of the Institute of Strategic and International Studies (ISIS), Malaysia, **Dr Gilberto M. Llanto**, President of the Philippine Institute for Development Studies (PIDS), Philippines, and **Dr Nguyen Dinh Cung**, President of Central Institute for Economic Management (CIEM), Vietnam. Dr Llanto congratulated the presenters for producing work that would have a great deal of practical utility to policymakers in the region and expressed his appreciation for the overall methodology used. He also mentioned that the data reflected a greater need for ASEAN's member states to collaborate and cooperate. Tan Sri Rastam commended ACI for the comprehensiveness of its methodology and echoed Dr Llanto's statements regarding the projects' practical utility. He also suggested that future iterations explore the growing relevance of research and innovation upon competitiveness. Dr Nguyen Dinh Cung also commended ACI for its methodology and concurred with the findings presented in the session. However, he did express his hope that future iterations of the ranking took into account the varying stages of development across ASEAN's member states.

The second session, entitled "2016 Annual Competitiveness Ranking and Simulation Studies on Six Regions and 33 Indonesian Provinces" was moderated by Mr Evan Tan Beng Kai, a Research Assistant at ACI. Presenters included Dr Mulya Amri, Research Fellow and Deputy Director (Research) of ACI, and Ms Nursyahida Binte Ahmad, a Research Assistant at ACI. The presenters showcased ACI's 2016 competitiveness rankings of the provinces and regions of Indonesia, explained ACI's competitiveness framework and methodology, and highlighted some interesting results from the 2016 Competitiveness Ranking and Simulations.

The discussant for the session was **Dr H. Abdul Hadi Sirat**, Director of the Khairun University Graduate School, Indonesia. Dr H. Abdul Hadi Sirat noted that ACI's yearly tracking of competitiveness provided insights into the Sub-National and regional economies that were unprecedented in their depth. He commented that this correspondingly enabled researchers and policy-makers to much more accurately assess the disparities between different Indonesian provinces, thus equipping them to craft more cohesive policies. However, Dr H. Abdul Hadi Sirat also questioned the nature of fluctuations in the rankings from year to year, cautioning ACI to consistently consider the sensitivity of their work on a wider political context.

The third session, entitled "Growth Slowdown Analysis by Income Thresholds for ASEAN Countries and Indonesia Sub-national Economies" was moderated by Ms Nguyen Le Phuong Anh, Research Fellow and Deputy Director (Admin) of ACI. Presenters included Mr Luu Nguyen Trieu Duong and Associate Professor Tan Khee Giap, respectively a Research Assistant and the Co-Director of ACI. After

briefly reviewing the history of income growth in the economies of ASEAN's member states and the Subnational economies of Indonesia, the presenters showcased empirical findings on different potential determinants of economic slowdown, all of which were grouped according to their effects on income groups. ACI's presenters also highlighted the possible applications of their work in predicting and thus potentially pre-empting regions of lower growth in Southeast Asia.

The session's discussants were **Dr Kirida Bhaopichitr**, Research Director of the Thailand Development Research Institute (TRDI), Thailand, Ms Kristy Tsun-Tzu Hsu, Director of the Taiwan ASEAN Studies Center at the Chung-Hua Institution for Economic Research, Taiwan, and Dr Darwin Marcelo, Infrastructure Economist at the World Bank Group. Dr Marcelo commented on the revelatory nature of ACI's findings regarding the correlation between the wealth of a given sub-national region and the likelihood that it would experience slowdown episodes. He did, however, note that the five-year window ACI had used to determine slowdown episodes seemed somewhat arbitrary, and asked if substituting different windows produced different results. Ms Hsu commended ACI for the timeliness of its analysis, given mounting concerns amongst researchers and policymakers alike regarding the 'Middle Income Trap' issue in ASEAN. She added that ACI's work would enrich the discussions ASEAN leaders were likely to have while consolidating future work programs for the region. Ms Hsu also recommended that ACI undertake a wider Asia-based analysis, which could include South Korea, Taiwan and Hong Kong. Dr Bhaopichitr commended ACI and its researchers for the work that had been done, but questioned the conclusions that had been reached regarding the effect of openness to trade and the old age dependency ratio on slowing growth. With regards to the former, she noted that the 'new normal' of slowing world trade meant that the correlation between lower openness to trade and slow growth was no longer a given. In addressing the latter, Dr Bhaopichitr suggested that allowing for greater immigration was a viable way to counteract slowing growth.

The fourth session, entitled "Ease of Doing Business Index on Attractiveness to Investors, Business Friendliness and Competitive Policies (EDB Index ABC) for Indonesian Provinces" was moderated by Dr Sasidaran Gopalan, a Research Fellow at ACI. The presenters were Associate Professor Tan Khee Giap, Co-Director of ACI, Dr Mulya Amri, a Research Fellow and Deputy Director (Research) of ACI, and Ms Nursyahida Binte Ahmad, a Research Assistant at ACI. The presenters introduced the "EDB Index ABC", which was designed to assess the ease of doing business in a given territory through the use of three broad environments – Attractiveness to Investors, Business Friendliness, and Competitive Policies. They also showcased applications of the Index to the provinces of Indonesia.

Discussants for the session included **Ms Paramita Dasgupta**, Practice Manager for Trade and Competitiveness in Asia for the World Bank Group, **Mr Supriyadi**, Head of Section for Trade and Telecommunications at the Indonesia Investment Coordinating Board (BKPM), Indonesia, and **Ms Kristy Tsun-Tzu Hsu**, Director of the Taiwan ASEAN Studies Center at the Chung-Hua Institution for Economic Research, Taiwan. Ms Hsu noted that ACI's proposed index had very comprehensively taken into account many factors which she felt Taiwanese investors in particular would deem important. She did suggest, however, that future iterations take into greater account the impact of infrastructure, regulatory procedures and government efficiency on Ease of Doing Business, given as they were noted by many Taiwanese investors to be major barriers to entry. Ms Dasgupta took note of the complementarity of the EDB Index ABC to the World Bank's own Doing Business (DB) survey, which functions at the national level. She also acknowledged the potential utility of the project, given the recent trend among large economies or federal states towards using subnational benchmarking to promote Sub-National competitiveness. Mr Supriyadi commended ACI for the work done on the survey and updated the audience on the work that had been undertaken by Indonesia in making itself friendlier to investors, and expanded upon the attractive investment opportunities the country now presented.

The fifth session, entitled "Impact of Real Effective Exchange Rates on Foreign Direct Investment Inflows to ASEAN Economies and Indonesian Provinces", was moderated by Mr Song Lin, a Research Assistant at ACI. The presenters were Dr Sasidaran Gopalan, Research Fellow at ACI, Ms Nguyen Le Phuong Anh, Research Fellow and Co-Director (Admin) of ACI, Dr Mulya Amri, Research Fellow and Deputy Director (Research) of ACI, and Mr Luu Nguyen Trieu Duong, a Research Assistant at ACI. The presenters introduced a model intended to help to identify the effects of Real Effective Exchange Rate (REER) appreciation and volatility on inflows of Foreign Direct Investment at the provincial level in Indonesia and at the national level for the economies of ASEAN's member states more generally.

The discussant for this session was **Dr Darius Tirtosuharto**, Economist at the Economic and Monetary Policy Department in the Macroeconomic Division of the Central Bank of Indonesia. Dr Tirtosuharto commended ACl's work both for its academic rigour, and its potential practical utility. He also suggested additional things to consider for future iterations of the project, including the significance of global and institutional factors, and the possible inclusion of productivity as a control variable, given its variability across national contexts and its effects on cost competitiveness.

The forum's closing remarks were delivered by **Dr Cledan Mandri-Perrott**, Head of Infrastructure Finance and PPP at the Infrastructure Finance Hub of the World Bank in Singapore, and **Professor Tan Kong Yam**, Co-Director of ACI. Dr Mandri-Perrott first expressed immense satisfaction at having had several intellectually rewarding discussions throughout the day. He then commented on the degree to which many of the questions asked at the Forum gestured towards a world of unpredictability and volatility, in which analytical paradigms used by various researchers and analysts would need to rapidly change to meet the needs of the elected officials who relied upon them to make informed decisions. Professor Tan reflected on the degree to which the changing circumstances that ASEAN members faced both as individual states and a united whole presented as many opportunities as it did challenges. Likening ASEAN during the Cold War to a lady bereft of suitors, Professor Tan observed that the ASEAN of today was contrastingly enjoying the attention of too many, and now needed to be judicious in her navigation of ongoing rivalries amongst them. Finally, Professor Tan thanked the audience for their contributions and brought the Economic Forum to a close.

He has also been profiled in the Economist and in Time Magazine. He is the author of five books: Can Asians Think?, Beyond The Age Of Innocence: Rebuilding Trust between America and the World, The New Asian Hemisphere: The Irresistible Shift of Global Power to the East, and The Great Convergence: Asia, The West and the Logic of One World. His books have been read and translated widely. The Great Convergence was selected by the Financial Times as one of the best books of 2013. His latest book is Can Singapore Survive? He graduated with a First Class honours degree in Philosophy from the University of Singapore in 1971. From Dalhousie University, Canada, he received a Masters degree in Philosophy in 1976 and an honorary doctorate in 1995. He spent a year as a fellow at the Center for International Affairs at Harvard University from 1991 to 1992. Prof Mahbubani was conferred The Public Administration Medal (Gold) by the Singapore Government in 1998. He was listed as one of the top 100 public intellectuals in the world by Foreign Policy and Prospect magazines in September 2005, and included in the March 2009 Financial Times list of Top 50 individuals who would shape the debate on the future of capitalism. He was selected as one of Foreign Policy's Top Global Thinkers in 2010 and 2011. In 2011, he was described as "the muse of the Asian century". Most recently, he was selected by Prospect magazine as one of the top 50 world thinkers for 2014

Darwin Marcelo is an economist and econometrician with extensive advisory, policy and analytical experience across infrastructure sectors. He retired from the civil service on 2 September 2010. Tan Sri Rastam is Chairman of the Malaysian National Committee for the Pacific Economic Cooperation Council (PECC), Chairman of the Malaysian National

Committee of the Council for Security Cooperation in the Asia Pacific (CSCAP) and CSCAP Co-Chair (2015-2017). He is also member of Asia-Pacific Economic Cooperation (APEC) Business Advisory Council – ABAC.

He was also Deputy Head, Department of Mathematics from July 1999 to June 2000. Prof Tan initiated the Special Programme in Science in 1996, the precursor of NUS' Talent Development Programme which was re-structured as the current University Scholars Programme. Prof Tan is a passionate teacher and has won several teaching awards at the University and Faculty level -- he was awarded the Innovative Teaching Award

1998 by the Faculty of Science; the Teaching Excellence Award for Innovative Teaching 1998 by the University; the Faculty Teaching Excellence Award 2004/2005; and the University Teaching Excellence Award 2004/2005. Currently, Prof Tan chairs the Management Board of the Risk Management Institute, NUS; and has been a member of the Management Boards of the Defence Science National Laboratories, MINDEF; Institute for Mathematical Sciences, NUS; Management Board, Singapore MIT Alliance and the MINDEF-NUS Temasek Laboratories, MINDEF. Prof Tan is also a Council member of the National Institute of Education, NTU. Prof Tan obtained his Bachelor in Mathematics (First Class Honours, 1985) at NUS and his PhD (1989) at Yale University. He joined NUS as a faculty member of the Department of Mathematics in 1985 (as a Senior Tutor) and has held visiting positions at various universities overseas such as the Rutgers University, University of Washington at Seattle, University of California at Berkeley and University of Maryland, USA; Universities of Tokyo and Kyoto, Japan; as well as the Hong Kong University of Science and Technology. Prof Tan is still an active national serviceman in Singapore, holding the rank of Deputy Superintendent of Police, and a command appointment as Commanding Officer of the Yishun South Neighbourhood Police Centre. He has also been active in promoting mathematics and mathematics education - he established the Singapore Mathematical Society Enrichment Programmes in 1994, revamped the Singapore Mathematical Olympiads in 1995 to allow more participation from students, as well as a series of workshops on the teaching of mathematics projects to teachers. He was Honorary Secretary, Singapore Mathematical Society from 1993 to 1995; serving as President of the Society from 2001 to 2005. He was also President of the South East Asian Mathematical Society from 2004 to 2005. Prof Tan's research interests are Representation Theory of Lie Groups and Lie Algebras; and Invariant Theory and Algebraic Combinatorics. His current research interests include econometric forecasting, cost of living index, global liveable cities index, ease of doing business index and competitiveness analysis on sub-national economies of China, India, Indonesia and ASEAN. Dr Tan was Deputy President of the Singapore Economic Society, 2004. He served in the 2002 Economic Review Committee (ERC), served as the Deputy Chairman of the IPS Forum for Economic Restructuring (IFER) in 2003 and served as a member of the Resource Panel of the Government Parliamentary Committee for Transport and Government Parliamentary Committee for Finance and Trade & Industry and Government Parliamentary Committee for Defence and Foreign Affairs since 2007. Dr Tan has extensively advised and guided multinational corporations leading to public listings especially those companies from Mainland China and Taiwan. He is also currently an Independent Director of the publicly listed Artivision, BreadTalk Group, Boustead Projects, TEE Land and Chengdu Rural Commercial Bank.

TAN Kong Yam

Professor Tan Kong Yam is presently the Co-Director of the Asia Competitiveness Institute. He is also Professor of Economics at the Nanyang Technological University. From 1985-89, he was the chief assistant to the late Dr Goh Keng Swee on his consultancy to Mr Deng Xiaoping on China's development strategy. From June 2002 to June 2005, he was a senior economist at the World Bank office in Beijing. In 2004, he was a member of the World Bank expert group on the eleventh five year plan (2006-2010) for the State Council in China. The expert group provided analysis and policy recommendations on urbanization, regional inequality, innovation policy, energy and water policy as well as strategy on banking reform to the Chinese government. Prior to that, he was the chief economist of the Singapore government (1999-2002), Head, Department of Strategy and Policy, Faculty of Business Administration at the National University of Singapore (NUS). He is a graduate of Princeton (1975-79, class of 1931 scholar, Paul Volcker Thesis prize) and Stanford University (1980-83), where he completed his Master and PhD in three years. Prior to joining NUS, he has worked at the Hoover Institution at Stanford University, World Bank, the Monetary Authority of Singapore, and was the Director of Research at the Ministry of Trade and Industry in Singapore. His research interests are in international trade and finance, economic and business trends in the Asia Pacific region and economic reforms in China. He has published ten books and numerous articles in major international journals including American Economic Review, World Bank Economic review, etc on economic and business issues in the Asia Pacific region. He served as board member at the Singapore Central Provident Fund Board (1984-96) and the National Productivity Board (1989-90). He has also consulted for many organizations including Temasek, GIC, Citigroup, IBM, ATT, BP, ABN-AMRO, Ikea, Bank of China, China Construction Bank, People's Bank of China, EDB, Areva, Capitaland, Samsung, Mobil, etc.

MOU will enable advanced policy research for sustainable development

Singapore, September 9, 2016 - The World Bank Group and the National University of Singapore (NUS) today signed a Memorandum of Understanding that will broaden collaboration in areas of shared expertise, in order to advance policy research that address global development challenges such as sustainable urban development and infrastructure finance.

The signing ceremony was held in conjunction with the Asia Competitiveness Institute – World Bank ASEAN Forum, which was hosted at the Lee Kuan Yew School of Public Policy (LKY School). Signatories for the MOU between the World Bank Group and NUS were Mr Jordan Z Schwartz, Director of the World Bank's Singapore Hub for Infrastructure and Urban Development, and Professor Tan Eng Chye, NUS Deputy President (Academic Affairs) and Provost. The signing was witnessed by Mr Ong Ye Kung, Singapore Acting Minister for Education (Higher Education and Skills) and Senior Minister of State for Defence.

"Singapore can share with the World Bank Group's member countries the lessons we have learned in creating a more efficient and livable city, in encouraging businesses to be more competitive and thrive, in providing quality health-care. NUS has strong knowledge and deep expertise in addressing critical issues that are relevant to Asia. We hope that our enhanced collaboration with the World Bank Group will further deepen our core strengths and at the same time enable NUS researchers to contribute towards the continued growth and development of Singapore as well as countries in Asia and beyond," said Professor Tan Eng Chye, Deputy President (Academic Affairs) and Provost, National University of Singapore.

The areas being considered for collaboration relate to key issues of sustainable economic development. In particular, they highlight the lessons learned by Singapore during its transformation from a low income country in the early 1960s to a leading manufacturing and services centre and among the world's most competitive economies.

For example, a proposed collaboration with the Centre for Livable Cities at the Ministry for National Development and the NUS School of Design and Environment's Centre for Sustainable Asian Cities will build on Singapore's expertise in fostering innovative urban growth and support of the development of smart cities in the East Asia and Pacific region.

The World Bank Group and Singapore have a long history of collaboration in promoting higher education, dating back to 1972 when the World Bank supported the development of a consolidated campus for NUS.

"In several critical areas of sustainable development - from integrated urban planning to innovative financing of infrastructure, from delivery of high-quality services to policies and technologies that increase competitiveness and connectivity — Singapore leads by example. Our collaboration with NUS is a reflection of both Singapore's academic excellence and extraordinary practical experience, and our efforts to provide development solutions for the World Bank Group's client countries," said Jordan Schwartz, Director of the World Bank Group's Singapore Hub for Infrastructure and Urban Development.

With the Institute of Water Policy at LKY School and the Temasek Foundation Water Leadership Programme, World Bank Group experts will work on strengthening the capacity of governments in Asia in undertaking climate proofing, integrated water management in cities, and water security.

In the realm of exploring scientific and technological solutions for health-care challenges, the World Bank will reach out to the Saw Swee Hock School of Public Health, Yong Loo Lin School of Medicine, Duke-NUS Medical School of NUS, and Biomedical Institute for Global Health Research and Technology (BIGHEART).

"This MOU will foster meaningful synergies between Singapore's research strengths and the World Bank Group's development functions, and also incorporate companies' feedback to augment the World Bank Group's suite of infrastructure solutions for developing countries. The World Bank Group's collaboration with a leading Singapore institution paves the way for impactful public-private partnerships to be driven from Singapore, to support the development of emerging markets in the region," said Lee Eng Keat, Director, International Organisations Programme Office, Logistics, and Natural Resources, at the Economic Development Board.

Other collaborations being proposed include support for learning opportunities through NUS' global education initiatives and joint research projects in the area of data analytics.

The expanding collaboration builds on the successful collaboration between the World Bank and the Asia Competitiveness Institute of the LKY School, which began in August 2015.

A Steering Committee – comprising of representatives from both institutions as well as local experts and stakeholders – will be established to provide overall guidance and supervision on the respective joint work programs.

Private sector companies and State-Owned Enterprises such as PSA International Pte Ltd, Changi Airport Group, SPRING Singapore, International Enterprise Singapore and Surbana Jurong Private Limited may serve as advisors in the projects. Moving forward, the International Finance Corporation, a member of the World Bank Group, may also explore potential collaboration with NUS.

NUS, World Bank to jointly study global issues

The World Bank and the National University of Singapore (NUS) have pledged to collaborate on research about global development challenges such as sustainable urban development and infrastructure finance.

They signed a memorandum of understanding yesterday in conjunction with the Asia Competitiveness Institute – World Bank Asean Forum at the Lee Kuan Yew School of Public Policy.

"Singapore can share with the

World Bank Group's member countries the lessons we have learnt in creating a more efficient and liveable city, in encouraging businesses to be more competitive and thrive, in providing quality healthcare," said Professor Tan Eng Chye, NUS' provost and deputy president for academic affairs.

For instance, the Centre for Liveable Cities at the Ministry for National Development and the NUS School of Design and Environment's Centre for Sustainable Asian Cities can offer expertise in innovative urban growth and smart cities in the East Asia and Pacific region.

As for scientific and technological solutions to solve healthcare challenges, the World Bank will work with the Saw Swee Hock School of Public Health, Yong Loo Lin School of Medicine, Duke-NUS Medical School of NUS, and Biomedical Institute for Global Health Research and Technology, among others.

The World Bank Group set up a hub in Singapore five years ago and now has about 140 staff here.

This is likely to grow to 220 staff in the coming years as the bank beefs up its operations, said Mr Jordan Schwartz, the director of the World Bank Group's Singapore Hub for Infrastructure and Urban Development.

NUS itself was built with the support of the World Bank in 1972, when the Singapore Government borrowed US\$9.5 million from the Bank to fund the construction of Singapore University (later renamed NUS).

Yesterday's MOU signing was witnessed by Mr Ong Ye Kung, the Acting Minister for Education (Higher Education and Skills) and Senior Minister of State for Defence.

调查: 新加坡整体竞争力亚细安第一

新加坡的整体竞争力排名继 续在亚细安独占鳌头,但作为一 个高收人经济体,我国面对经济 增长放缓的可能性也最高,概 率为44.5%、远超其他亚细安国 家。

我国在政府和机构环境方面 的竞争力出现小滑落;而交通和 人力成本如今是我国的"最弱一 环"。

新加坡国立大学李光耀公共 政策学院亚洲竞争力研究所2013 年度最新调查昨天公布,我国分 别在整体竞争力、宏观经济稳定 性、金融与商业和人力状况、生 活素质和基础设施发展、政府与 机构环境等环节,维持亚细安第 一的优势。

政府与机构环境得分滑落

其中,我国在前四个环节中 的竞争力均有进步;但在政府与 机构环境的得分则稍有滑落, 这 也是过去三年来我国首次在这个 环节中退步。

这份调查是根据121个指标来衡量亚细安十国的竞争力,首次发表于2003年。由于收集数据和公布数据之间需要时间,因此2013年的得分和排名是最新的数据。

过去14年,新加坡的亚细安第一位置从未动摇。排在我国之后的目前依次是: 马来西亚、泰国、文莱、印度尼西亚、菲律宾、越南、柬埔寨、老挝、以及缅甸。

排名第二的马来西亚,竞争 力在2012年至2013年显著退步。 它在五个环节中的得分不仅全数 倒退,在宏观经济稳定性方面, 还被泰国超越,落居第三。这也 使新马之间的差距有所扩大。

不过,亚洲竞争力研究所 所长陈企业副教授接受《联合 早报》访问时强调,在过去14年 里, 马来西亚在金融商业和人力 方面的竞争力, 已越发接近新加坡, 这主要跟我国的商业空间租 金高昂, 以及劳动力短缺有关。

他表示,整体竞争力而言, 马来西亚仍与新加坡有很大一段 距离。

121个指标当中,我国的交通 拥堵指标得分最低、流入的外国 直接投资指标得分最高。

从经济增长角度来看,新加坡面对的风险也不容忽视。我国经济在2012年至2017年放缓的概率是44.5%,另七个受调查的亚细安国家所面对的风险,不超过29.8%。

报告说: "人口少加上人力 成本上升,正在威胁新加坡对跨 国企业的吸引力,尤其是当人口 既多又年轻,且劳动力教育水平 新高的新兴市场涌现。新加坡要 成功转型为知识型经济体、减少 对外国直接投资的依赖,必须加 强本地的中小企业。"

"Our collaboration with NUS is a reflection of both Singapore's academic excellence and extraordinary practical experience, and our efforts to provide development solutions for the World Bank Group's client countries," commented Mr Schwartz. He shared that LKY School was a natural partner, given that tools of financing must go hand-in-hand with public policies that build capacity, efficiency and sustainability. "That LKY School is the only institution in Singapore named after Lee Kuan Yew is even more apt. As Lee Kuan Yew said, we are seeking to establish '... a framework within which we can learn, work hard and be productive..." Mr Schwartz believes that a long-term commitment to collaboration with NUS across curricula could contribute to achieving such a framework.
