Students who have previously enjoyed government subsidy or sponsorship by a Singapore government agency (such as scholarships offered by the Ministries, Public Service Commission and Statutory Boards) in a graduate programme will not be eligible for Ministry of Education (MOE) subsidy in another graduate programme at the same or lower level. Instead, such students will be liable to pay "Non-Subsidised Fees", inclusive of prevailing GST. For example, students who had previously enjoyed subsidies/scholarship in a Master programme and had attained the Master degree will not be eligible for subsidies in another programme at Master or lower level.
