- Develop a more nuanced understanding of key issues in Asia;
- Discuss and debate with subject experts about the dynamics of geo-politics in the region and global implications;
- Analyse and challenge ideas, to become better critical thinkers, change agents and leaders; and
- Forge deeper connections with Young Global Leader peers and strengthen international networks.

The Insights into Politics and Policy in Asia for Global Leaders Course is specially designed for members of the Young Global Leaders of the World Economic Forum. The World Economic Forum has established a comprehensive selection process to identify the most outstanding young leaders around the world and recognise them for their individual professional accomplishments and commitment to society, as well as their potential to provide inspiring leadership. Young Global Leaders who want to have a deeper understanding of how to keep pace with the changing global dynamics in order to effectively address some of the most pressing issues facing our world today are invited to apply.

The two day programme will be concluded with a "Future Thinking Debate" amongst YGL participants.

Interaction, discussion and debate will be emphasised throughout the two day programme. Delegates will be expected to contribute to the discussions with their experience, thereby enhancing their own learning and that of other participants, therefore a minimum level of command of the English language is required.

During the Course, delegates will have the opportunity to practice some of the ancient philosophies around inner balance that the region is known for, and look at how this can benefit personal and professional life.

The Course will be held at Lee Kuan Yew School of Public Policy at the National University of Singapore's Bukit Timah Campus, next to the Botanic Gardens







FEES

This programme is made possible through the support of Lee Kuan Yew School of Public Policy, and as such tuition is free. Refreshments and lunch will be provided. However travel, accommodation, insurance and any other incidentals are the responsibility of participants.

WITHDRAWAL FEE

Withdrawals must be received in writing by both the Lee Kuan Yew School of Public Policy and the Young Global Leaders team. There is a cancellation fee of 500CHF for withdrawals notified between 4 weeks and 2 weeks before the programme start date, and a 1,000CHF cancellation fee for later cancellations or no shows.

ADMISSION

Applications will be assessed by an independent panel and you should expect to receive a response by Friday 13 July 2012. Criteria will be the quality of thought put into to the essay questions.
