# SYNOPSIS

## **Special Session: Changing Global Supply Chains**

The Special Session aims to examine the changing global supply and value production chains and in relation to Singapore as a trading hub. For countries such as Singapore, changes in the global supply chain have enormous impact on the economy. Challenges and opportunities will present themselves as Singapore continues its path up the value chain. It is therefore important to ensure that businesses in Singapore are aware of these changes and the potential benefits they can gain by adapting well and leveraging new opportunities that are likely to emerge.

Some of these changes include the impact of external headwinds such as the Sino-US trade war, which has seen companies stockpiling critical production parts and seeking new suppliers and customers in various sectors. This has caused shifts to the global supply and production chains. For example, Vietnam, Thailand, Malaysia and parts of Africa have become new popular destinations for manufacturing firms. Additionally, China has developed its innovation base and is increasingly becoming part of the higher-value production network. The Belt and Road initiative has also increased the construction of new production sites in other countries.

# **BIOGRAPHICAL NOTES**

**BHASKARAN, Manu** is Adjunct Senior Research Fellow at the Institute of Policy Studies. He is concurrently Partner and Member of the Board, Centennial Group Inc, a policy advisory group based in Washington DC, where he heads the Group's economic research practice. Mr Bhaskaran co-leads the Institute's work in the area of economics. His major area of research interest is the Singapore economy and the policy options it faces. Prior to his current positions, he worked for 13 years at the investment banking arm of Societe Generale as its Chief Economist for Asia. He began his professional career at Singapore's Ministry of Defence, focusing on regional security and strategic issues. Mr Bhaskaran graduated from University of Cambridge with a Master of Arts and also has a Masters in Public Administration from Harvard University.

**FARRIS, Ray** is Credit Suisse's Managing Director and Chief Investment Officer for South Asia, in its International Wealth Management's Investment Solutions and Products department. Prior to this, Mr Farris was at various times the Chief Economist for APAC, in the Investment Solutions and Products department of the International Wealth Management division; Head of Fixed Income Research and Economics, Asia Pacific Division; Head of Asia Macro Strategy; Head of Global Emerging Markets Strategy; Head of the Asia-Pacific Macro Product Research; and Head of Global Foreign Exchange Strategy (based out of London from 2007 to 2011). He joined Credit Suisse in February 1998 from BZW Asia, where he was Senior Economist in the equity division. Mr Farris holds a degree in Economics with highest honours from the University of North Carolina at Chapel Hill, and a Master's degree in Finance with distinction from London Business School.

**GOH, Mark** holds the appointments of Director (Industry Research) at the Logistics Institute-Asia Pacific, at the National University of Singapore (NUS) — a joint venture with Georgia Tech — and Principal Researcher at the Centre for Transportation Research, also at NUS. He was a Program Director of the Penn-State NUS Logistics Management Program. He was Regional Director of Supply Chain Solutions for Asia/Middle East with APL Logistics, crafting logistics engineering solutions for major multinational corporations. Dr Goh was a Board Member of the Chartered Institute of Transport (Singapore), past Chairman of the Academic Board of Examiners for the Singapore Institute of Purchasing and Materials Management, member of the Advisory Committee of the Transportation Resource Centre (NUS), and a past Vice President of the Operations Research Society of Singapore. He was a member of the Global Advisory Council (GAC) on Logistics and Supply Chain with the World Economic Forum. Dr Goh holds a PhD from the University of Adelaide.

**ONG, Christopher** heads up DHL Express in Singapore as Managing Director. Responsible for driving profitable and sustainable business growth in the country, Mr Ong is also a member of the DHL Express Asia Pacific Management Board. Prior to this appointment, he was Managing Director for DHL Express Vietnam (2011–2014) and DHL Express Malaysia and Brunei (2014–2018). Mr Ong joined DHL Express in October 2006 as Vice President, Business Development at the Asia Pacific Regional Office and was responsible for Mergers and Acquisitions, Partnerships and Planning for the region.

In his early career, Mr Ong spent about 10 years with Temasek Holdings, the Singapore government-owned sovereign wealth fund, where he was responsible for originating, evaluating and executing investments as well as managing and restructuring companies around the globe. Mr Ong graduated Summa Cum Laude with a Bachelor of Science in Mechanical Engineering from Tufts University.

**TAN, Alex** is a Senior Research Fellow at the Institute of Policy Studies, the premier public policy think-tank in Singapore. He leads the data analytics and consulting work on economic policy, focusing on the future economy, industry transformation (e.g., financial services), human capital, and small and medium enterprises. Dr Tan was previously an award-winning professor of innovation and entrepreneurship, dedicating eight years to teaching and research in Australia, Singapore and the United States. He has a Doctorate in Business Administration from the University of Hawai'i, and Master's and Bachelor's degrees in Economics and Computer Information Systems from the State University of New York.

**TAN Boon Heng** is a Senior Economist in the Economic Policy Group of the Monetary Authority of Singapore (MAS). He joined the MAS in 2016 and is currently in the modelling division, operating and maintaining MAS' suite of macroeconomic models of Singapore. Mr Tan is an alumnus of the National University of Singapore.

**TEATHER, Edward** is an Executive Director and Senior Economist in UBS' Asian Economics Team, which has been a top-ranked team in several institutional investor surveys. Mr Teather specialises in ASEAN economies (Indonesia, Malaysia, Singapore, Thailand and the Philippines) while looking at the Asian economy more broadly. He joined UBS in 1998 and worked initially in UBS' Global Economics Team. For eight years prior to his current role, he was an economist based in London, where his responsibilities included coverage of the European Area, and the German, Spanish, Italian and Scandinavian economies. Mr Teather is a United Kingdom national and has lived in Singapore since 2007. He studied economics at the University of Surrey in the United Kingdom and the University of North Texas in the United States.
