Track 3: Online Harms, Freedom of Speech and Digital Citizenship

The advent of the Internet and social media has turbocharged communications and ushered in an era of unprecedented connectivity, transforming the way we live, learn and interact. However, the digital world can sometimes appear lawless, as bad actors exploit technology to perpetrate scams, cyber-bully, distribute non-consensual sexual content (including child abuse, revenge porn and deepfakes) and wage disinformation campaigns. Our youths are especially vulnerable, as digital natives who spend significant time online. How can laws and governance frameworks uphold accountability and behavioural norms online, safeguard trust and balance freedom of expression with the need to prevent harm? How can personal responsibility be enhanced? This track will explore how different stakeholders – including the Government, industry partners, community organisations, and individuals – can strengthen trust, prevent harm and secure remedies in the digital world; and how the next generation can navigate the online space safely and responsibly as empowered digital citizens.
