# Pre-Conference Session Cities, Civilisations and Geopolitics:

In Conversation with George Yeo and Liu Thai Ker

From ancient Greece to renaissance Italy, city-states have in history defined the contours of geopolitics and geo-economics in regions across the world. While the Treaty of Westphalia would give rise to an international system that is dominated by nation-states and civilisational states, cities continue to play an important role in the global political economy. In this pre-conference session, we will situate the city in its historical and geopolitical context. What is the role of the city in an increasingly state-centric and multi-polar international system? What lessons can we learn from historical cities and city-states?

At the heart of these debates is Singapore, which exists as both a city and a sovereign state. How can Singapore as a city-state navigate an increasingly complex and turbulent world? What lessons can we learn from other cities and city-states in history?
