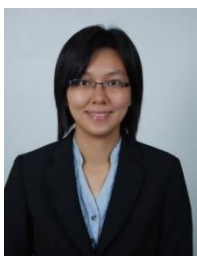
Editor-in-Chief – Phua Chao Rong, Charles

Charles Phua Chao Rong is a pracademic and civil society leader: Deputy Director (Designate) for Centre for Liveable Cities, Ministry of National Development (Singapore), concurrently Lee Kong Chian scholar/ final year PhD Candidate in Public Policy at Lee Kuan Yew School of Public Policy (LKYSPP).

An academic, he is a Fulbright Fellow and non-resident Senior Fellow at East West Institute (New York) with 13 essay awards (including first prize Chief of Defence Force essay competition) and 46 (including commissioned/forthcoming) publications. Charles also serve as Assistant Editor for Comparative Public Policy Series (Cambridge University Press), Editor-in-Chief of Asian Journal of Public Affairs, and sits on Editorial Boards of POINTER (SAF Journal) and International Relations and Diplomacy. He did his undergraduate and Research Masters in International Relations at London School of Economics and holds a Specialist Postgraduate Diploma from National Institute of Education. His research interests include Public-Business-Not-for-Profit Management, Corporate-Military-Public Sector Strategy, International Relations, Security Studies, East-Southeast Asian studies, American, Chinese and Singapore studies, Innovation and Thinking, Research Methods and Philosophy of Social Sciences.

A practitioner, he was Head Research Trainer at Ministry of Defence Training Captains and Majors in research work. He spearheaded two military start-ups, was Deputy Lead for Singapore's contingent in Afghanistan, and served as President's Honorary Aide-de-Camp for 6 years. Charles' 15-year civil-society leadership record from London to Singapore included spearheading five civil society start-ups, being the first Singaporean to run Commonwealth Youth Forum in Malta, spearheading inaugural international Youth Olympics community song album, two MINDEF-wide charity carnivals involving 4,000 and raising \$61,000, Global Social Innovators Forum, and recently the nation-wide SG100 (self-raised \$200,000 sponsorship from public-private-people sectors) for Singapore's youths to discuss vision and policy recommendations for SG100 nation-building, as President of Association for Public Affairs. He also served as a SPRING's Business Excellence assessor offering advice on strategic planning and organisational excellence to heads of public and private organisations, and is the youngest Singapore Scout Council member. He is a NIQCC and IETEX judge, and volunteers with Facilitator Network Singapore as a process facilitator.

The first Singaporean recipient of Goldman Sachs Global Leader and HSBC Youth Excellence Awardee, Charles consistently excelled internationally to be named World Economic Forum Global Shaper, CSIS Pacific-Forum Young Leader, Thai Institute of Justice Fellow, and inducted into Stars 'Next Generation Leader' and Dragon 100 (for Chinese young leaders) networks.



Deputy Editor-in-Chief –Si Ying Tan

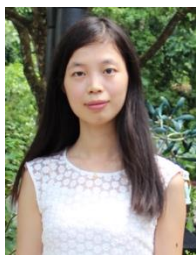

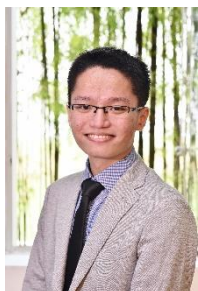


Editor – Shruti Singh
